Cracking financing bottlenecks will be fundamental to increase domestic resources mobilization for the water and sanitation sector. Collective efforts are needed to create enabling environment for service providers and users to ensure that financial mechanisms are set up and regulations are in place to support sustainable and resilient infrastructure

**Session Description:** 

To address financing in WASH challenge, development partners, governments, major investment banks and other international organizations are discussing how to move this agenda forward. In 2015 in Addis Ababa and Dakar many countries have agreed to increase domestic resources mobilization to ensure access and sustainable management of water and sanitation for all. With limited public funding, this requires the development an innovative approaches to water financing that can leverage grant, tax and private money, expanding the reach of the beneficiaries.

This event will provide participants with the latest thinking on financing drawing on the conclusions of the 2016 Financing Events in Addis and Dakar and the financial plans for SDGS. Participants will have opportunity to discuss and reflect on country case studies and examples that the Dutch ministry of Foreign Affairs, has launched in collaboration with other partners such us UNICEF, World Bank, IRC, Netherlands Water partnership. Some practical examples such us Kenya innovative finance facility and country case on leverages will be discuss.

> for practical implementation of Climate Change Resilience projects. On the background of high level of vulnerability in Africa and high level of uncertainty in Climate Projections, and based on practical examples from projects on the ground.

**Session Description:** Getting the right design is critical for financing of any infrastructure. Key design

parameters for water infrastructure are hydrological information. In many countries this information is scares and the uncertainties introduced by climate change makes projections even more difficult. Existing climate models are not detailed enough to produce scenarios at local level. With these uncertainties there is a risk of building too small or too big infrastructure and there is a need to agree on a policy and a practical approach to define critical water resources information.

Financing mechanisms: Financing for project identification, project preparation and project implementation; Identification is done locally as part of national planning processes; Preparation are often done through project preparation facilities such as African Water Facility, and sometimes as part of investment; Actual investment is done as part of development banks (AfDB, WB etc) or form dedicated climate change investment options such as GCF.

**Session Objectives:** The objective of the topic is to learn from cases about how country-led monitoring has

improved WASH services and water quality, water resource management or faecal sludge management, where it has developed and how it can be strengthened to meet

the diverse sector information needs.

Session Description: Country-led monitoring is when the government leads and owns the monitoring cycle

by determining questions to be asked, methods applied, analytical approaches, communications and how the information is used. Resulting national M&E systems are a crucial part of the enabling environment to improve services at sub-national and

national levels and to track and meet N'gor, SDG and SWA commitments.

There is demand for data for all these different purposes and an expectation that partners align with country-led monitoring systems. How can this be done? Cases will be presented on the use of data from country-led monitoring systems for their core purpose: to improve services. Following this, there will be examples of how systems have been developed at scale and a panel discussion on their role in meeting diverse/

aligned data needs.

Session Description: AMCOW Ministers made decisions both at the General Assembly and Executive

Council levels to institute the African Water and Sanitation Sector Monitoring and Evaluation Process. Further, the AMCOW Executive Committee (EXCO) during its 2015 meeting made a decision (EXCO/12/2015/DAKAR/1) directing the AMCOW Secretariat to develop mechanisms for linkages with the monitoring, evaluation and reporting processes at Global level including Post 2015 SDG monitoring initiatives with the Africa Monitoring and Reporting System. At global level, various monitoring and reporting initiatives are being developed to support SDG 6 monitoring and

reporting.

The session will outline the processes and how the Africa Water and Sanitation Sector has evolved over the years. This session will also provide an overview of some of the new SDG monitoring complexities at global level and discuss the implications for countries and present steps to ensure linkages across different levels.
